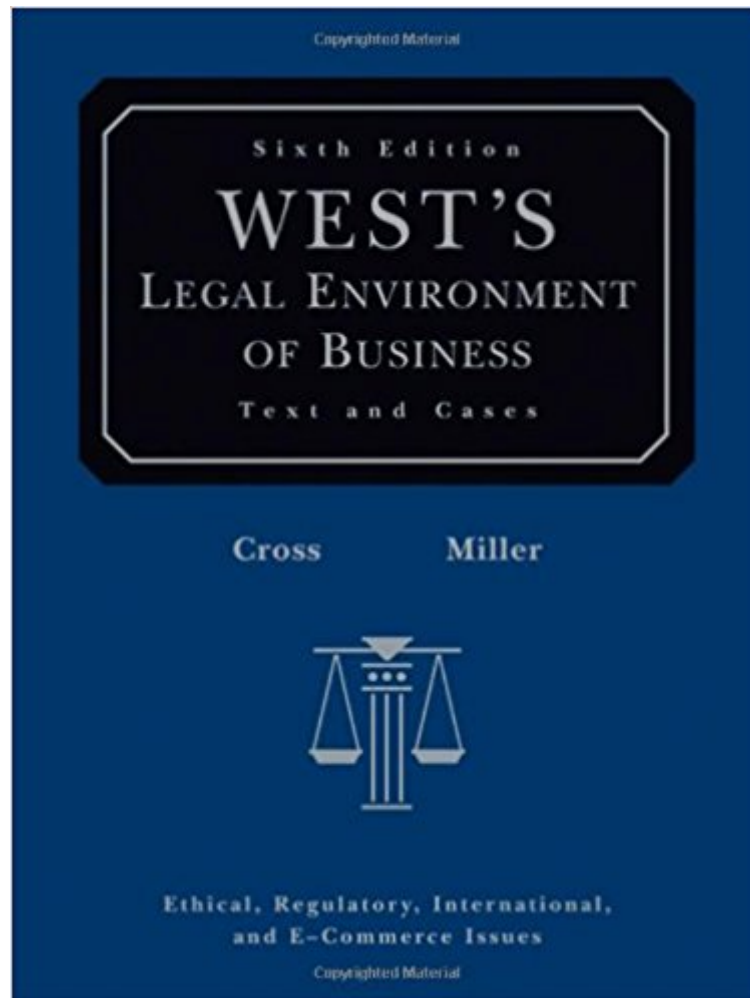

Kelleher Centennial Professor of Business Law at The University of Texas at Austin Law School, where his research centers on judicial decision-making, the economics of law and litigation, and traditional policy and doctrinal issues in administrative law. He has written several books as well as pieces for the YALE LAW JOURNAL, COLUMBIA LAW REVIEW, UNIVERSITY OF CHICAGO LAW REVIEW, NEW YORK UNIVERSITY LAW REVIEW, TEXAS LAW REVIEW, VIRGINIA LAW REVIEW, CORNELL LAW REVIEW, GEORGETOWN LAW JOURNAL, NORTHWESTERN LAW REVIEW, and UCLA LAW REVIEW. A former president of the Academy of Legal Studies in Business, Professor Cross received his B.A. from the University of Kansas and J.D. from Harvard Law School. Roger LeRoy Miller has served on the faculty of several universities, including the University of Washington, Clemson University, and the University of Miami School of Law. As professor he has taught intellectual property law, entertainment law, and other

subjects.
