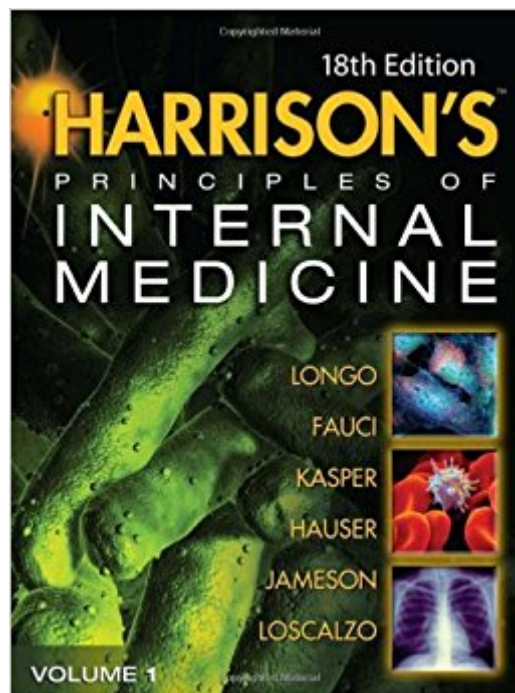

First of all, my comment specifically addresses the kindle edition and the technical side of it. As for the content, the book is amazing - no complaints there. seems not to understand or just ignore the difference between fiction books that you read from page one onwards, possibly in one sitting, and academic handbooks. I bought the book for my new iPad mini and as it is - it's nearly useless. By buying this, you end up with a bunch of over 4000 numbered pages of text in digital format, just like you would scan the paper version. 1. There is no clickable or expandable table of contents. 2. You can't do full-text search, actually there is no text search at all. 3. There are no hyperlinks, the Index section is also plain text - no clickable reference to the actual pages. Someone missed the possibilities that digital format gives and just took the path of the least resistance. I will be asking for a refund. If you are considering buying the kindle edition for your iPad, consider Inkling edition, which is a bit more expensive but a lot more useful.

This book is a must for any clinician or advanced health care student. It's big, it's comprehensive, and there's a lot of information there. The one complaint I have is that there is a bit TOO much information at times (and it's heavy to carry around!). Having a lot of info can be a double edged sword! But overall, a great reference.

They have kept the font tiny for the last 25 years and I guess they won't change now. One drawback of Harrison's is it is short on management and long on genetics, pathophysiology etc.

Very comprehensive and up to date on all the topics (for internal medicine, that is). The only problem is because there is just too much new knowledge over time, so some important topics are "off-loaded" onto the accompanying CD. And I have misplaced that. So until I can locate that CD, I am ignorant of such things as poisoning and environmental toxins, among other things. Oh well, I hope they can expand the next edition to three or more volumes instead so I won't misplace my CD.

I was disappointed to find that not only are there no hyperlinks through the text, even the table of

contents does not click through to the relevant chapter, and nor does the index. The most basic kindle books from the very first kindle, for free, usually have this ability. Of course the content is there (doesn't work in android galaxy s4 by the way, even though the screen should have an adequate resolution for it), but don't expect to do some quick fact checking using this e-paperweight.

Up to date as every one of the previous versions I know. This is my first version as e-book and I am surprised how easy it is to navigate and read on your PC or tablet. However navigation on iPad is not so easy as on your PC because the actual page-numbers are mixed up with the number of physical pages. Having said this, more hyperlinks could have made my rating 5-starred
